## **AKC Sanctioned 4-6 Month Beginner Puppy Competition**

**Date of Show - May 3, 2019 - AM SESSION**

**Fee - \$10.00**

Section 1 - Classifications - The Four-to-Six Month Puppy Competition shall be for dogs that are four months of age and over but under six months of age on the day of the show.

**This is a combined class for dogs and bitches**

Section 2 - Entry and Eligibility and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for all entries.
- A foreign born dog may enter this class if they are registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog. Dogs may not be exhibited by current assistants and household members of a professional handler.
- Use regular entry form and put 4-6 month puppy in the dog show class space

### **Non-regular Classes Involving Multiple Dog Entries**

Stud Dog Class    Brood Bitch Class

**Stud Dog** - for Stud Dogs and at least two of their get. Stud dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of the Stud Dog need not necessarily be owner of Get. Get only to be judged, based on the merits of the Get. An entry of \$30.00 will be charged for each dog making up the entry (Stud Dog and two of its Get). If they are not entered individually in one of the Regular Classes, Best of Breed Competition or some other Non-regular Class other than Stud Dog.

**Brood Bitch** - Same as Stud Dogs about substitute Brood Bitch for Stud Dog and Produce for Get.

### **\*AMATEUR-OWNER-HANDLER CLASS (Effective 1/1/2009)**

The Amateur-Owner-Handler Class shall be for dogs that are at least 6 months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog. This class is restricted to exhibitors who at any point in time, been a professional dog handler, AKC approved conformation judge or employed as an assistant to a professional handler. Additionally, members of the immediate family of household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13).

### **\*\*BRED-BY-EXHIBITOR CLASS ELIGIBILITY (Revised 9/2002)**

All dogs entered in the Bred-By-Exhibitor Class must be individually registered with the AKC. The person handling the dog must be a breeder of record and owner of record of the dog. To exhibit in this class, family members must be a breeder and owner of record.

**OPEN JUNIOR CLASS:** For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Showmanship Class at a licensed or member show.

**OPEN INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN SENIOR CLASS:** For Boys and Girls who are least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Showmanship Class at a licensed or member show.

**MASTER CLASS:** This Class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed.
