### **BEST OF BREED COMPETITION**

### 4 TO 6 MONTH BEGINNER PUPPY CONFORMATION - AM SHOW

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Class is not divided by sex.

AKC registration number or AKC Litter number will be required for all entries.

A foreign born dog may enter this class if they are registered in the country of origin.

All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.

Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog. Dogs may not be exhibited by current assistants and household members of a professional handler.

Use regular entry form and put 4-6 month puppy in the dog show class space.

### **NON-REGULAR CLASSES (Involving Multiple Dog Entries)**

**Stud Dog**: For Stud Dogs and at least two of their Get, Stud Dogs must be entered in the Stud dog class and must be shown in the ring with their Get. The owner of the Stud dog need not necessarily be the owner of the Get. Get must be entered in regular or non-regular class. Get only to be judged, based on Get's merit.

**Brood Bitch**: Same as for Stud dog class except substitute Brood bitch for Stud dog and Produce for Get.

### \*\*BRED-BY-EXHIBITOR (BBE) CLASS ELIGIBILITY (Revised 9/2002)

All dogs entered in the Bred-By-Exhibitor Class must be individually registered with the AKC. The person handling the dog must be a breeder of record and owner of record of the dog. To exhibit in this class, family members must be a breeder and owner of record.

### **JUNIOR SHOWMANSHIP CLASSES**

**Novice Junior**, For boys and girls at least 9 yrs of age and under 12 yrs of age on date of show and have not won three 1st places with competition in a Novice class at a licensed or member show.

**Novice Intermediate,** For boys and girls at least 12 yrs of age and under 15 yrs. age on date of show and have not won three 1st places with competition in a Novice class at a licensed or member show.

**Novice Senior**, For boys and girls at least 15 yrs of age and under 18 yrs of age on date of show and have not won three 1st places with competition in a Novice class at a licensed or member show.

**Open Junior**, For boys and girls at least 9 yrs of age and under 12 yrs of age on date of show and have won three 1st places with competition in a Novice class at a licensed or member show.

**Open Intermediate**, For boys and girls at least 12 yrs of age and under 15 yrs of age on date of show and have won three 1st places with competition in a Novice class at a licensed or member show.

**Open Senior**, For boys and girls at least 15 yrs of age and under 18 yrs of age on date of show and have won three 1st places with competition in a Novice class at a licensed or member show.

**Master**. For boys and girls who are at least 9 yrs of age and under 18 yrs on the day of show and have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship.

\* NOHS - All dogs in the BOB competition (including WD & WB) will stay in the ring after the judge makes their placements in BOB competition. The ring steward will ask all professional handlers, household members and current assistants to professional handler to leave the ring and then the judge will then select the Best Owner-Handled (BOH)

**From South via NJ Turnpike** – Take Tpk. North to **Exit 10** and follow signs for I-287 North. Follow I-287 N to Exit 14B for Route 22 West. Go west 2.5 miles to exit for Route 202 / 206 South. Follow signs for Route 202 South - Flemington, which takes you over the Somerville traffic circle. About 2 miles past circle after you go under a RR bridge turn right onto Milltown Road. North Branch Park is about 0.4 miles up road on your left.

**From East or South via I-287 North** – **Exit at 14-B** for Route 22 West. Go west 2.5 miles to exit for Route 202/206 South. Follow signs for Route 202 South-Flemington, which takes you over the Somerville traffic circle. About 2 miles past circle after you go under a RR bridge turn right onto Milltown Road. North Branch Park is about 0.4 miles up road on left.

**From North via Route I-287 South** - Take I-287 South to **Exit 17** - Routes 202/206 South Somerville / Flemington. Follow signs for Route 202 South / Flemington, which takes you over the Somerville traffic circle. About 2 miles past this circle after you go under a RR bridge turn right onto Milltown Road. North Branch Park is about 0.4 miles up road on your left.

From West or East via I-78 – Follow signs for I-287 South and then follow directions above.

**From West via Route 202 North** – About 10 miles past the Flemington traffic circle look for a right jug-handle exit to go left onto Milltown Road. Cross over Route 202 and continue for about 0.4 miles to North Branch Park, which will be on your left.

**CLOSING DATE** for entries 5:00 PM, Wednesday, April 15, 2020 (at Show Secretary's Office) after which entries cannot be accepted, cancelled or substituted except as provided for in Chapter 11, Sect, 6 of the Dog Show Rules.

A RECORDING FEE of \$.50 and an AKC EVENT SERVICE FEE of \$3.00 will be required for each Dog entered at any Licensed or Member Club Show. These Fees are to be collected by the Show-giving Club and paid to the American Kennel Club. If a Dog is entered in more than one class in the show, the Fees are to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2).

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS AND PHOTOCOPIES OF ENTRY Forms without the Agreement and Rules on the reverse side of the Official AKC Entry Form and NOT acceptable. ENTRIES RECEIVED WITHOUT FEES will not be accepted.

**ACKNOWLEDGEMENT OF ENTRIES** will be made as soon as practicable. SHOULD SUCH NOT BE RECEIVED BY THE EXHIBITOR within a reasonable time, notify **LYDIA STRAUSS, Show Sect., 917-941-2223**.

**ENTRY FEES** shall not be refunded in the event that a Dog is absent, disqualified, excused by Veterinarian or Judge, or barred from Competition by action of Show Committee. If, because of riot, civil disturbance or other acts beyond the control of the Management, it is impossible to open or to complete the show, no refund of entry fee will be made.

**ERRORS ON ENTRY BLANKS**. Owners are responsible for any errors made on entry forms. No entry fee will be refunded in event of such errors or of the cancellation of entries after the published closing.

**NO REFUND FOR DUPLICATE ENTRIES**. We will make every effort to find all duplicate entries, but if a Dog has been processed, no refund will be made.

**DOGS MAY ARRIVE** any time prior to their scheduled judging times. Dogs not required for further judging will be excused. All dogs present **MUST** be held on leash or confined to their crates, except when being judged.

**JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS**. Owners or agents are responsible for the presence of their Dogs in the judging ring when their classes are called to be judged. The Show-giving Club has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**THE SHOW COMMITTEE** will use due care and diligence for the welfare of Dogs and Exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either Dogs or Exhibitors participating in this Show.

**Effective May 1**st, **2016**, an administrative fee of \$2.00 will be withheld from all refunds for entries cancelled prior to the closing date.
